*Government Notice No. 173 of 2004***THE MAURITIUS ACCREDITATION SERVICE ACT****Regulations made by the Minister under section 14 of the
Mauritius Accreditation Service Act**

1. These regulations may be cited as the Mauritius Accreditation Service (Laboratory Accreditation Fees) regulations 2004.

2. In these regulations –

“Act” means the Mauritius Accreditation Service Act;

“assessment” means a set of activities, including a visit, undertaken by MAURITAS to ensure that an applicant or accredited laboratory operates in compliance with the accreditation requirements;

“calibration fields” means the fields, as specified in the First Schedule, in which calibration operations are to be carried out;

“man-day rate” means the amount of money payable by an applicant or accredited body to MAURITAS for assessment or surveillance conducted by an assessor for one day’s duration;

“site” means any location where testing or calibration activities are being carried out;

“surveillance” means an on-site visit undertaken by MAURITAS to an accredited laboratory at periodic intervals to verify whether that laboratory is operating in compliance with the accreditation requirements;

“testing fields” means the fields, as specified in the First Schedule, in which tests are to be carried out by scientific methods.

3. For the purposes of section 8(3) (c) and 10(2) of the Act, the fees payable shall be the amounts specified in the Second Schedule.
4. The application fee payable under section 10(2) of the Act shall be non-refundable.
5. An accredited body shall pay an assessment fee, based on a man-day rate of 10,000 rupees, to MAURITAS in respect of assessment and surveillance activities conducted by it.

*Government Notice No. 19 of 2007***THE MAURITIUS ACCREDITATION SERVICE ACT**
Regulations made by the Minister under Section 14 of the
Mauritius Accreditation Service Act

1. These regulations may be cited as the Mauritius Accreditation Service (Certification Body Accreditation Fees) Regulations 2007.

2. In these regulations —

“Act” means the Mauritius Accreditation Service Act;

“assessment” means a set of activities, including a visit, to ensure that an applicant or accredited certification body operates in compliance with the accreditation requirements set by MAURITAS;

“assessor” means a person assigned by an accreditation body to perform, alone or as part of an assessment team, an assessment of a conformity assessment body;

“expert” means a person assigned by an accreditation body to provide specific knowledge or expertise with respect to scope of accreditation to be assessed;

“man-day rate” means the amount of money payable by an applicant or accredited body to MAURITAS for assessment, or surveillance conducted by an assessor for one day's duration;

“programme” means an accreditation programme operated by MAURITAS, as specified in the First Schedule.

3. These regulations shall apply to certification bodies only.
4. For the purposes of sections 8(3)(c) and 10(2) of the Act, the fees payable shall be as specified in the Second Schedule.
5. An application fee payable under section 10(2) of the Act shall be non-refundable.
