THE MAURITIUS ACCREDITATION SERVICE ACT**Regulations made by the Minister under section 14 of the Mauritius Accreditation Service
Act**

1. These regulations may be cited as the **Mauritius Accreditation Service (Laboratory Accreditation Fees) (Amendment) Regulations 2013**.
2. In these regulations —
“principal regulations” means the Mauritius Accreditation Service (Laboratory Accreditation Fees) Regulations 2004.
3. Regulation 2 of the principal regulations is amended by —
 - (a) deleting the definition of “man-day rate”;
 - (b) inserting, in the appropriate alphabetical order, the following new definitions —

“assessor” means a person assigned by an accreditation body to perform, alone or as part of an assessment team, an assessment of a conformity assessment body;

“expert” means a person assigned by an accreditation body to provide specific knowledge or expertise with respect to the scope of accreditation to be assessed;
4. Regulation 5 of the principal regulations is revoked and replaced by the following new regulation —

5. A laboratory shall pay, where applicable, travel and accommodation costs, and travelling time in addition to the assessment fee.

 5. The Second Schedule to the principal regulations is revoked and replaced by the Second Schedule set out in the Schedule to these regulations.

 6. These regulations shall come into operation on 25 February 2013.

THE MAURITIUS ACCREDITATION SERVICE ACT**Regulations made by the Minister under section 14 of the Mauritius Accreditation
Service Act**

1. These regulations may be cited as the **Mauritius Accreditation Service (Certification Body Accreditation Fees) (Amendment) Regulations 2013**.
2. In these regulations —

“principal regulations” means the Mauritius Accreditation Service (Certification Body Accreditation Fees) Regulations 2007.
3. Regulation 2 of the principal regulations is amended by deleting the definition “man-day rate”.
4. The principal regulations are amended by adding new regulation -
 6. A certification body shall pay, where applicable, travel and accommodation costs, and travelling time in addition to the assessment fee.
5. The First Schedule to the principal regulations is amended by adding the following new item —
 8. Certification of persons
6. The Second Schedule to the principal regulations is revoked and replaced by the Second Schedule set out in the Schedule to these regulations.
7. These regulations shall come into operation on 25 February 2013.
